## 9.1.1 Support for Mental Health CARRIED

BCSTA request that Government supports the creation of a working group
 Consisting of BCSTA, applicable Ministries, Rights Holders, and Partner Groups to prepare a
 recommendation to the Ministry of Finance that will provide incentives for Child Youth Mental Health
 Clinicians, as well as Indigenous Practitioners to locate in rural and remote Communities to meet the needs
 of Children and Youth in said communities. The work is desired to be completed prior to the tabling of the
 Provincial Budget in 2024.

## 9.1.2 Pay Equity Supplement Advocacy CARRIED

That BCSTA advocate to the Ministry of Education and Childcare and the Ministry of Finance to
increase the Pay Equity Supplement to ensure that the Districts that had addressed or partially
addressed pay equity using their own operating dollars prior to the instituting of the Pay Equity
Supplement are provided an increase to bring them up to the current median Pay Equity Supplement
based on FTE and that no District is negatively impacted

# 9.1.3 Request for the Minister of Education and Childcare's Support for Equity, Diversity and Inclusion CARRIED

That the BCSTA urge the Honourable Rachna Singh, Minister of Education and Childcare to write a
letter and release a statement committing to the values of equity, diversity and inclusion in the BC
school system and including the human rights of transgender and other 2SLGBTQ+ students and
staff, as well as addressing the misinformation being disseminated publicly regarding SOGI 123
resources.

# Improving Student Outcomes - Data Presentation - Ministry of Education and Childcare

- Discussion around what data is and the types of data quantitative (survey, admin, aggregate, record level) and qualitative (personal observations, anecdotes, experiences). There are also additional perspectives to consider including socio economic (this isn't always the way it seems), indigenous ways of knowing.
- What you should know: enrolment and demographics priority populations, indigenous (how are we
  doing report), students with designations, ELL, enrolment projections, completion rates, assessment
  results FSA, Grad Assessments, student learning surveys and workforce data
- How to use what you know comes from building trust be curious and ask questions. Building capacity ask questions and learn. Build confidence don't let paralysis by analysis become a barrier. Also recognize when a distinction is not a cost/time effective or when it is.
- Take your personal biases out of decision making. Sometimes your ideas are just 1 offs, it's
  important to see if the statistics are actually telling you what you think there are. Always remember
  to take in the context within the data
