Dear BC School Board of Education Trustees,

We are writing about the upcoming Motion 15, which will be coming to the BC School Trustees Association at the AGM in April. The motion is regarding the use of seclusion rooms. It looks to create benchmarks and best practices by collecting data and analysis. Safe and Inclusive Schools are trauma-informed schools. When we support those with the most complex needs appropriately, the entire educational community is supported and successful.

The benefits of implementing alternative approaches to seclusion range from staffing costs and turnover to reduced mental health impacts, which again support traumainformed practices.

There is no compelling case that seclusion supports educational practices or learning outcomes. There is much evidence to show the harm that it causes, however.

Please vote in favour of Motion 15 at the AGM.

In our annual Exclusion Tracker, we have found that restraint and seclusion continues to happen in BC schools. In terms of exclusion, Indigenous, Black, and immigrant children and youth seem to be disproportionately impacted. We are concerned that this may extend to restraint and seclusion as well.

Inclusion BC has done two reports so far on these practices, Stop Hurting Kids 1 and 2:
